## **Invitation to Comment**

We invite you to assist us in the development, evaluation, and implementation of the Title I Program. Title I is a federally funded program for elementary, middle, and high schools. Through this program, the government provides financial assistance to school districts based on family income at each school. The Title I program is designed to ensure that all participating children have a fair and equal opportunity to obtain a high-quality education while providing an enriched and accelerated educational program.

We invite you to submit comments regarding the Title I program. To ensure that your comments have maximum value in helping us develop the final plans, we urge you to identify clearly the specific needs for the programs to address. Programs to be discussed include: The Comprehensive Local Education Agency Implementation Plan (CLIP) review, and Flexible Learning Plans (FLP) requirements Plan.

**CLIP** is a comprehensive district plan based upon multiple data sources regarding district goals for the year and how resources will be coordinated to meet the identified needs of the school district.

**FLP** is an intervention program for Title I Priority schools and Focus schools. The program provides additional instruction or educational programs for eligible Title I students and serves as an alternative supplemental academic intervention that allows the school district greater flexibility in designing extended learning programs. FLPs are tailored to the needs of the school and provides students with additional learning opportunities.
